English classes will be held in the morning beginning **at 8:30am** and Western Classes to follow. Entries close on April 15<sup>th</sup> and Ride times will be emailed by **Wednesday (April 22nd)** and posted on VAHA website (www.vintagearabian.com). Late entries will be considered time permitting. **Ribbons 1<sup>st</sup> through 5<sup>th</sup> place.**

Stalls are available for \$30 per day/night. Fee includes (1) bag of shavings. Checks are to be made out to Woodland Stallion Station. Contact, Keila Golden to reserve a stall 530-505-1090.

This show, in principal, will follow USEF rules pertaining to tack, bits, and equipment. Formal attire and braiding are not required. However, care should be given in presenting a neat appearance to the judge. **ALL MOUNTED RIDERS MUST** wear boots. English mounts must wear approved ASTM/SEI helmets regardless of competition level, and age. Western classes can wear a suitable Western hat, or ASTM/SEI helmet. All classes will be held in outdoor standard size dressage arena, 20m x 60m. Lunging and warm ups to be done in designated arenas. Management reserves the right to limit class size.

It is your responsibility to familiarize yourself with the USEF, USDF, CDS, WDAA show rules and the CAWDA qualification rules for the yearly High Point Program. All exhibitors must abide by the rules of the show facility, WSS.
