English classes will be held in the morning beginning **at 8:30 am**. Western Classes will be held in the afternoon beginning at approximately **1:00 pm**. Ride times will be emailed the Sunday before the show. Late entries will be considered time permitting.

This show, in principal, will follow USEF rules pertaining tack, bits, and equipment. Formal attire and braiding are not required. However, care should be given in presenting a neat appearance to the judge. **ALL MOUNTED RIDERS MUST** wear boots and approved ASTM/SEI helmets regardless of competition level, and age. All classes will be held in outdoor standard size dressage arena, 20m x 60m . Lunging and warm ups to be done in designated arenas. Management reserves the right to limit class size.

It is your responsibility to familiarize yourself with the USEF, USDF, CDS and WDAA show rules. All exhibitors must abide by the rules of the show facility, WSS.
